**WAIVER OF LIABILITY**

I acknowledge that this Waiver and Release of Liability Form will be relied upon by, and will ensure to the benefit of, all such parties, and it will govern my actions and responsibilities at said event.

In consideration of permitting me to participate in this event, I hereby, for and on behalf of myself, my administrators, heirs, next of kin, successors, and assigns:

- A. ## Vendor's Instructions/Policy

### Canada Day July 1<sup>st</sup>, 2016 – Port Credit Memorial Park

- **Once accepted, all vendors must provide a Certificate of Insurance with a minimum of \$2,000,000.00 liability, naming Paint the Town Red Port Credit Community Association and the City of Mississauga as additional insurers. Please let me know if you need insurance.**
- All Minor-Food and Major- Food vendors must submit completed Environmental Health forms required by the Region of Peel Public Health Department. Forms are available at the Region of Peel Health website or by contacting the Vendor Co-ordinator.
- All Vendors shall be open between the hours of 1:00pm – 11:00pm. Vendors shall maintain their area clean.
- All vendors must provide their own set-up such as: tent(s), tables, chairs, lighting, extension cords etc. (weights to hold tents down are mandatory). Set-up may be done on Thursday June 30<sup>th</sup>, 2016 by previously arranging with Beatrice Moreira-Laidlow, Vendor Co-ordinator via email: [beatrice@portcredit.com](mailto:beatrice@portcredit.com)
- Vendor Permits are obtained by Vendor Coordinator and held in binder on site, as per Bylaw.
- All vendors may drive their vehicle in the park to unload and once unloaded, **during set times only** the vehicle must be parked at the Go Station parking lot opposite to the Port Credit Arena. All vendors agree not to drive their vehicle back in the park until, after closing and clearance has been given by the Vendor Co-ordinator.
- All vendor spaces are 10'x10', you will need to bring your own extension cord(s) (100') minimum. (Power bars are useful). **Food vendors must provide power requirements at least 2 weeks prior to the event**
- Paint the Town Red Port Credit Community Association reserves the right to select the vendors as well as to limit the amount of vendors and allocate appropriate space location according to vendor's needs.
- Payment accepted only by money order or certified cheque.
- Paint the Town Red Community Association reserves the right inspect your display during the event and ask you to remove any items that were not on your list upon applying.



Please make sure to read all the instructions/policy requirements and regulations before signing the Vendor Agreement. Space is limited, so please submit your application as soon as possible.

Applications without payment or signed waiver will not be considered and priority will be given to completed applications. Application deadline is: **May 1, 2016**

**No refunds will be issued for cancellations unless notified in writing 30 days prior to the event. No exceptions.**
