

WAIVER OF LIABILITY

As the authorized representative of _____ an organization at which minor age children participate in one or more performance forms, I hereby, for and on behalf of myself and such organization ASSUME ALL OF THE RISKS OF PARTICIPATING IN AND PERFORMING AT the Paint The Town Red Port Credit Community Association's Canada Day Celebration event, and hereby release, remise and discharge all the parties identified herein of and from, including by way of example and not limitation, any risks that may arise from the negligence of such parties, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault. I acknowledge that this Waiver and Release of Liability Form will be relied upon by, and will enure to the benefit of, all such parties.

In consideration of permitting minor children associated with such organization to participate in this event, I hereby, for and on behalf of myself, my administrators, heirs, next of kin, successors, and assigns and such organization and its directors, officers, employees, representatives and agents :

- A. WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, costs, expenses, claims, or actions of any kind which may hereafter occur to me including my travelling to and from this event, THE FOLLOWING ENTITIES OR PERSONS AND THEIR ASSETS: The Paint The Town Red Port Credit Community Association and its directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors, activity or event volunteers and participants; and the City of Mississauga and its elected Council, officers, employees, representatives and agents;
- B. INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the parties identified in the above paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by their negligence or otherwise.

I acknowledge that The Paint The Town Red Port Credit Community Association and their directors, officers, employees, volunteers, representatives, and agents, and the City of Mississauga and its elected Council, officers, employees, representatives and agents, are NOT responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of Paint The Town Red Port Credit Community Association.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any purpose by the event holders, producers, sponsors, organizer, and assigns.

This Waiver and Release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
