- C. AGREE TO COMPLY with all applicable laws and regulations imposed by any government agency, as well as all rules, policies and requirements relating to or forming part of such event. Vendor's Instructions/Policy

CANADA DAY CELEBRATIONS, JULY 1<sup>ST</sup>, 2024 – Port Credit Memorial Park

- Once accepted, all vendors must provide a Certificate of Insurance with a minimum of \$2,000,000.00 liability, naming Paint the Town Red Port Credit Community Association and the City of Mississauga as additional insurers.
- All Food vendors must submit completed Environmental Health forms required by the Region of Peel Public Health Department. Forms are available at the Region of Peel Health website or by contacting the Vendor Coordinator.
- All Vendors shall be open during set hours of operation and **ready to go by 12 Noon.**
- All vendors must provide their own set-up such as: tent(s), tables, chairs, lighting, extension cords, water hoses etc. (weights to hold tents down are mandatory). Set-up may be done on Sunday, June 30, 2024 by previously arranging with the Vendor Coordinator via email: [pttrvendor@gmail.com](mailto:pttrvendor@gmail.com)
- Vendor Permits are obtained by Vendor Coordinator and kept on site as per Bylaw.
- All vendors may drive their vehicle in the park to unload and once unloaded, the vehicle must be parked at the GO Station parking lot opposite the Port Credit Arena. All vendors agree not to drive their vehicle back in the park until after closing and all clear has been given by the Vendor Coordinator.  
**No vehicles are permitted in the park after 12 noon.**
- All vendor spaces are 10'x10'.
- Vendors must provide power requirements. You will need to bring your own extension cord(s) (100' minimum). (Power bars are useful).
- Paint the Town Red Port Credit Community Association reserves the right to select the vendors as well as to limit the number of vendors and allocate appropriate space location according to vendor's needs.
- Paint the Town Red Community Association reserves the right to inspect your display during the event and ask you to remove any items that were not on your list upon applying.

Please ensure to read all the instructions/policy requirements and regulations before signing the Vendor Agreement.

- Space is limited, so please submit your application as soon as possible.
- Applications without payment or signed waiver will not be considered and priority will be given to completed applications.
- Application deadline is: 5:00pm May 31, 2024.

No refunds will be issued for cancellations unless notified in writing 30 days prior to the event. No exceptions.

A \$150 administration fee will be charged for cancellations.
